The approved candidates should be provided engagement against the post for which his/her candidature was approved.

It is the responsibility of the appointing authority to ensure genuineness of educational qualification of the candidate considered for compassionate engagement.

All the files listed in **Annexure-I and Annexure-II** are returned herewith for taking further necessary action.

Speaking orders of not recommended cases mentioned in Annexure-II are enclosed for arranging delivery of the same under proper acquittance and copy of the acquittance may be sent to Circle Office for record. Kindly acknowledge the receipt of this letter along with files by return post.




