Subject: Limited Departmental Competitive Examination (LDCE) from Postman/Mail Guard & MTS & MTS(CO/RO) for the vacancy year 2021 and Competitive Examination for GDS for vacancy year 2021 for recruitment to the cadre of Postal Assistant/ Sorting Assistant held on 21.11.2021 and DEST on 30.01.2022 – Declaration of Mail and Surplus result of Bihar Circle.

In pursuance of Directorate letter no. A-34012/05/2021-DE Dated 10.09.2021 and Circle Office Patna letter no. R&E-52/LGO Exam/2021(PM/MG/MTS), R&E-52/LGO Exam/2021(GDS) & R&E-52/LGO Exam/2021(CO/RO) Dated 13.09.2021, the notification for LDCE for promotion to the cadre of PA/SA from eligible Postman/Mail guard/MTS & GDS were issued on 13.09.2021. In the said notification it was announced to conduct the above examinations for the vacancy year 2021 on 24.10.2021 but due to Bihar Panchayat Election the date of exam was rescheduled on 21.11.2021 as per Directorate letter no. A-34012/01/2021-DE Dated 18.10.2021. Accordingly examination of Paper-I & II were conducted on 21.11.2021 and Data Entry Skill Test (DEST) Paper-III on 30.01.2022.

Now, the results were prepared as per guidelines of Directorate issued vide letter no. 04-08/2019-SPN-I dated 26.7.2019, 06.09.2019 & 11.12.2020 and letter no. 17-08/2018-SPB-I dated 09.09.2021, 20.6.2019 & 10.05.2019.

2. On successful completion of aforesaid examination, provisional answer keys (MCQ) for Paper-I & II (in series A,B,C & D in both papers) inviting feedback/challenges from candidates were uploaded on indiapost website on 24.11.2021. And based on responses received from candidates, answer keys for Paper-I & II have been finalized and uploaded on indiapost website on 04.01.2022. The list of candidates who have qualified in Paper-I & II was prepared separately for LGO candidates and GDS candidates and the same was uploaded on Indiapost website on 21.01.2022.

3. In pursuance of Annexure — C of Directorate letter No. 17-08/2018-SPB-I dated 10.05.2019 read with letter dated 26.06.2019 selection has been made strictly on merit based on marks secured on Paper-I only. Paper-II in Regional Language is considered as qualifying and the score in Paper-II has not been taken into account for assessment of merit and following are the qualifying criteria for each paper of PM/MG/MTS & GDS to PA/SA Examination:-

INSTRUCTIONS


1. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/ appointment letters issued.

2. The selection has been made based on merit in the examination vis-a-vis date of birth has been made as next criterion in case of equal marks of two or more candidates and the older candidate has been given preference over the younger candidate for GDS candidates and Date of joining in case of Departmental employees as per instructions of Directorate issued vide letter no. 04-08/2019-SPN-I dated 11.12.2020.
3. If any disciplinary/vigilance case is pending against the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
4. Provisional Candidate: The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates and if found in the list of selected candidates, they should not be given promotion/ appointment under any circumstances without regularization of candidature and the same may be brought to the notice of Circle Office, Patna.
5. It is informed that the name of the candidates have been arranged in the order of merit and their allotment to the Division/Unit as per order of preference in accordance with Directorate guidelines issued vide letter no. 02-01/2018-SPB-I dated 07.02.2019.
6. As per Directorate letter no. W-04/2/2020-SPN-I-Part(I) Dated 19 October, 2020 Postman/MTS/GDS selected for appointment to the posts of PA/SA, whether through competitive examination or seniority, shall be appointed straightway after completing pre-appointment formalities without waiting for completion of prescribed institutional induction training.

The Divisional/Unit Heads will take further necessary action for circulation of the content of this communication to all concerned. Also efforts should be made for appointment of selected candidates on or before 15.02.2022. This issues with the approval of the Competent Authority.
