I am directed to intimate that Limited Departmental Competitive Examination among MTS(CO/RO) for promotion to Postal Assistant(CO/RO) for the vacancies of the year 2021 (01.01.2021 to 31.12.2021) was held on 24.10.2021 followed by DEST held on 13.02.2022 as per the notification issued vide this office letter No.RE/APCO/3-5/PA(CO-RO)/DP/2021 dated 13.09.2021 and 22.09.2021 in accordance with the Directorate instructions contained in Letter No:17-08/2018-SPB-I dated 10.05.2019, as amended vide letters of even no. dated 10.06.2019, 20.06.2019, 28.06.2019, 11.07.2019, 23.07.2019, Letter No. 03-03/2019-SPN-I dated 19.06.2019 and Letter No:17-08/2018-SPN-1 dated 09.09.2021.

In pursuance of Directorate instructions contained in Letter No:17-08/2018-SPB-I dated 10.05.2019, the candidates who qualified in Paper-I, Paper-II and Paper-III separately shall be considered for final selection and their Merit shall be drawn in order of marks secured in Paper-I since both Paper-II and Paper-III (DEST) are qualifying in nature.



Also, it is advised to re-check the pre-requisite conditions prescribed for candidate, with reference to their recommendations made while forwarding the application forms.

6. In case, at any time, it is detected that the candidate so selected had applied and appeared the examination with false declaration or data, his/her selection will be cancelled without any notice.

8. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. It is directed to verify the current status of the candidature of the qualified candidates before promoting the official.
9. It may be ensured to cause timely issuance of appointment letter so that official can join in the respective office of posting at the earliest as per extant rules.
