The promotion of above officers is purely on ad-hoc basis at circle level short term officiating arrangement for a period 11 months from the date of joining or until further orders, whichever is earlier. The service rendered on ad-hoc basis will not count for the purpose of regular promotion in the higher grade for seniority in the said grade.


This ad-hoc promotion will be stood terminated automatically on joining of regular incumbent or on expiry of period of 11 months from the date of assumption of charge if not extended, whichever is earlier.

In case any vigilance / disciplinary case is pending or any punishment is current against the officers, they should not be relieved / promoted before expiry of current punishment without obtaining specific orders from C.O. Ahmedabad.

In case, officer is not willing to accept his promotion, his declination letter in writing should be sent within 30 days from receipt of this order, failing which it will be presumed that he has declined the promotion.

The officers are directed to relieve themselves under office arrangement and join their new place of posting immediately.

No leave should be granted to the above officers till they join their new assignments.

The competent authority is pleased to issue orders of transfer / posting of officers of PS Gr.B Cadre of the Region in the interest of service or otherwise with immediate effect.


