Division/Unit will prepare a consolidated list and send it to this office latest by 20-08-2023.
  - (b) Photocopies of Answer sheets will be supplied to only those candidates who appeared in the examination. Therefore the candidates should invariably intimate their Roll Number in the application under RTI Act 2005. Requests of persons other than the candidates for supply of answer papers etc will not be entertained by this office.
3. The name/roll number/community of above candidates is as per the information received from Unit if however any mistake in the name/roll number/community of candidate is noticed the same may be corrected and intimated to this office immediately.
4. As per Directorate's instructions, Revaluation of answer scripts is not permissible in any case or under any circumstances.
