This is in continuation of this office Memo Nos. referred above vide which result of MTS to PM-MG (Parent & Surplus) for the vacancy year 2023 have been declared. Now, the competent authority is pleased to announce further result of LCE for recruitment to the cadre of PM-MG from eligible GDS (Parent) for the vacancy year 2023 held on 30-04-2023 followed by Data Entry Skill Test (DEST) held on 19-08-2023 as under:

- 2 As per Directorate's instructions issued vide letter no: 17-08/2018-SPN-I dated 5<sup>th</sup> April, 2022 and 17-08/2018-SPN-I dated 15<sup>th</sup> June, 2022, the selected GDS candidates have been allotted to Home Divisions / Units as per their merit (Total Marks in Paper-I & II) as per availability of vacancies, in the Division / unit and as per relevant Recruitment Rules & instructions on the subject.
- 3 The Final Answer Keys of Paper-I, II and Paper-III of aforesaid LDCE / LCE were already displayed on India Post Website i.e. [www.indiapost.gov.in](http://www.indiapost.gov.in). The selection of the candidates is based on the eligibility criteria for qualifying in the examination issued vide this office Notification of even no. dated 16-03-2023 and relevant rules & instructions issued by Department from time to time.
- 4 Details of Departmental /Direct Quota Vacancies in accordance with the extant rules / guidelines issued by Directorate time to time has already been issued vide this office letter No. R&E/1-1/Vacancy/PM-MG/2023 dated 16-10-2023.
- 5 In case of deciding inter-se rank / merit in case of more than one candidate scoring equal marks, instructions contained Directorate's letter no: 04-08/2019-SPN-I dated 11-12-2020 has been followed.
- 6 Before appointment, it should be ensured that Directorate Guidelines / Instruction in respect of Disciplinary / Vigilance clearance issued vide Memo No. X-7/6/2022-SPN-II dated 17-05-2023 & 22-09-2023 should be adhered.

- 7 The candidates of reserved category i.e. SC/ST/OBC/EWS/PH who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the roster. Further, the recruitment of reserve category candidates is provisional subject to verification of their caste/ PH / category certificate.
- 8 The information relating to the Names of the candidates, their Roll numbers, names and community have been shown on the basis of information furnished by the Heads of Regional / Divisional office. The Head of the Divisions / Units are requested that particulars of Successful candidates, viz. Roll numbers, names, community and their eligibility to appear in the said examination, are re-checked and ensure that the selected candidates fulfil all required conditions of relevant Recruitment Rules before declaration of their result. The Divisional Units Heads are advised to re-check all the pre-requisite criteria / conditions prescribed for candidates, with reference to their recommendations made while forwarding the application form. They will also check that number of such candidates allotted to their Units is not more than the number of vacancies proposed to be filled through the said examination.
- 9 In case, if it is found subsequently that any of the selected candidate(s) was not eligible to appear in the examination under the existing Rules/Instructions on the subject or for any reasons or in case any discrepancy is found with regard to announcement of Result of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letters issued.
- 10 In respect of SC/ST/OBC/EWS/PH candidates, "promotion of the candidates is provisional subject to verification of their caste status. Head of the Unit will take an undertaking from the officials to this effect at the time of their relieving and ensure verification of caste / category status within one month".
- 11 This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing Rules and instructions on the subject. It may be ensured that no Provisional candidate is given appointment without regularization of the candidature and such cases need not to be kept pending except in very exceptional & unavoidable circumstances.
- 12 Appointment orders will be issued in case of these successful candidates clearly indicating that if the official does not join the promotional post within Seven (07) days it will be deemed to have been refused. Official on leave may be allowed to join even after seven days if they communicate in writing to accept the promotion and in that case the official will be allowed after expiry of approved leave period. (Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing.)

The candidates who are unwilling to accept promotion, he / she should submit two original copy of his / her unwillingness to the Head of Parent Division in the prescribed performa at the earliest. The candidates already selected in PA/SA/PM/MG/MTS should also submit their unwillingness, if any. One copy of unwillingness may be forwarded to this office without fail.

- 13 The Division/Unit Heads should ensure timely issue of offer of appointment letters **not later than 11-03-2024** to the successful candidates so that the selected candidates/officials join in their respective office of posting immediately as per extant rules. **Joining process must be completed by 18-03-2024 in any circumstances.**
- 14 The Division/Unit Heads should ensure that if the selected candidate is transferred to other Division/Circle under Rule-3 then the copy of result should be forwarded to transferee Division immediately for further course of action under intimation to allotted division/unit.
- 15 The Divisional/Unit Heads are also requested to ensure timely issuance of appointment letters so that officials can join in their respective offices of posting at the earliest. The guidelines issued vide Directorate letter No. W-04/2/2020-SPN-1-Part (1) dated 19.10.2020 may be taken into consideration while issuing appointment order.
- 16 Requests for re-totalling / revaluation will not be entertained in the light of instructions of the Directorate. Photocopies of Answer Sheets will be supplied to the candidates, on submission of application under RTI Act, only on furnishing OMR form No. and Roll Number.
- 17 Applications under RTI Act for supply of photo copied of OMR/answer sheets will be entertained in the following manner:
- d) Candidates, who wish to have the copies of Answer Sheets supplied, are required to pay a fee of Rs.25/- per paper with key plus Rs.10/-towards fee for application under RTI Act in the post office accounts and submit their applications through the Division/Unit concerned along with the receipt for payment of fee in original.
  - e) A copy of this letter with Annexures has been uploaded on [www.indiapost.gov.in](http://www.indiapost.gov.in). Requests for supply of these documents under RTI Act will not be entertained.
  - f) The prescribed period of preservation in respect of OMR / Answer sheets is one year from the date of declaration of this result. Therefore, application received after one year from the date of declaration of result for supply of photocopies of OMR / answer sheet will not be entertained.
- 18 It should be ensure that if any selected candidates had decline the promotion in past, he / she should not be promoted till the completion of One year from the date of his / her declination as per the Directorate New Delhi's Memo No. W-17/10/2023-SPN I DOP dated 06-03-2023. Concerned Divisional / Unit Heads are requested to ensure the same and intimate to this office about the same.
- 19 Appointment of selected candidates should be processed expeditiously observing usual formalities and departmental guidelines issued and circulated from time to time.
