Subject: LDCE for promotion to the cadre of Postal Service Group 'B' for the vacancy years 2018, 2019 & 2020, held on 29.11.2020 –results/marks of Sealed Cover /Deemed Sealed Cover candidates.

Madam/Sir,

I am directed to refer to this office letter of even number dated 01.06.2022 whereby the result of the LDCE for promotion to the cadre of Postal Service Group 'B' for the vacancy years 2018, 2019 & 2020, held on 29<sup>th</sup> November, 2020 was declared.

2. A list of sealed cover / deemed sealed cover was also appended as Annexure – 'C' with the said letter dated 01.06.2022. Sh. Priya Ranjan, one of the applicants of the above LDCE whose result was kept in sealed cover, approached Hon'ble CAT, Patna Bench through OA No. 516/2022 with the prayer to declare his result. Hon'ble CAT, Patna Bench passed an order dated 06.10.2023 and directed the Respondents to consider the case of the applicant for promotion to the post of Postal Service in Group-B cadre in accordance with his performance in the LDCE within a period of two months from the date of receipt of this order."

3. The Competent Authority, after perusal and consideration of the order dated 06.10.2023 of Hon'ble CAT, opinion of Branch Law Secretariat, Kolkata, advice of Additional Solicitor General, Patna High Court and proposal of Bihar Circle has accorded approval to implement the said orders of Hon'ble CAT, Patna Bench and ordered to open the sealed cover of all the similar situated candidates. Accordingly, the latest Vigilance / Disciplinary status reports received from the Circles have been reviewed and found that Forty (40) candidates were free from vigilance angle on the last date of application (i.e. 06.11.2020) and were subsequently proceeded with disciplinary/criminal proceeding and their currency of penalty was also over before the date of declaration of results (i.e. 01.06.2022).

4. Accordingly, the results of these 40 candidates are declared and appended as:

- (i) **Annexure- I** - containing the names of 6 (Six) candidates who have been selected for the vacancy years noted against their name.
